The HCWRT Presents Dr. Andrew Lang Speaking on:

"In the Wake of War"

Union armies during the American Civil War did not merely engage Confederate forces in open battle, waging the grand, romantic campaigns of national lore. Approximately onethird of Union soldiers also occupied vast regions of the Confederate South, populating scores of garrisons across an antagonistic wartime landscape. There, the uncertain and often confusing dynamics of military occupation exposed United States soldiers to a unique kind of warfare waged far beyond the front lines that few volunteers imagined when they enlisted in the nation's loyal armies.

Prof. Andrew F. Lang will explore the unanticipated but far-reaching challenges of military occupation during the American Civil War and its immediate aftermath. Military occupation proved to be a trying component of the Union's military strategy, exposing fault lines within nineteenth-century American military and But occupation political culture. itself demonstrated a critical and dynamic component of a war to preserve the Union and secure emancipation. Prof. Lang will engage contemporary artistic renditions to demonstrate how the essential but complex nature of Civil War-era military occupation reflects the United States' enduring challenge of waging war in search of a just and lasting peace.

About Andrew Lang

Andrew F. Lang, who received his PhD in 2013 from Rice University, is an associate professor of history at Mississippi State University. He is the author of *In the Wake of War: Military Occupation, Emancipation, and Civil War America,* published by LSU Press in

2017. The Society of Civil War Historians honored the book with the 2018 Tom Watson Brown Book Award, bestowed each year to "the best book published on the causes, conduct, and effects, broadly defined, of the Civil War." He is the author most recently of A Contest of Civilizations: Exposing the Crisis of American Exceptionalism in the Civil War Era, which is the final installment of the Littlefield History of the Civil War Era, published by the University of North Carolina Press. In addition to co-editing a volume of scholarly essays on Civil War-era military history, Prof. Lang has published pieces in The Atlantic, Washington Post, Wall Street Journal, and Civil War Monitor. He is currently writing an intellectual biography of Abraham Lincoln's nationalism, concept of Union, and philosophy of history.

The 2021-22 Speakers Campaign opens with the September meeting, when Professor Andrew Lang will present his topic "In the Wake of War" which will analyze the post-war Reconstruction period and the experiences of the military occupation of the South. This topic is also very timely, as I will continue to encourage future presentation that not only focus upon the generals and battles of the Civil War, but the issues and events before and after that continue to impact America today in profound ways. This meeting will also contain many of the older, traditional elements of our Round Table, including a book signing by the speaker and our book raffle.

I had hoped to announce the annual national meeting of the Civil War Round Table Congress which was scheduled for the weekend of September 17th in Philadelphia, Pennsylvania. This meeting has been an excellent format for the sharing of ideas and experiences from round tables around the country. Unfortunately, COVID again altered those plans, and the meeting has been postponed indefinitely. I will keep the group updated on future meeting plans.

NEW MEETING VENUE, FORMAT, AND SAFETY MEASURES By Scott Wilkey, Communications Chair

You can imagine our excitement (no doubt you shared it with us) when we could announce the resumption of in-person meetings at HCWRT speaker engagements. It is wonderful to imagine starting our 2021-22 campaign under a "normal" set of circumstances. The past few weeks however, have given us all pause as we watch news of the new "delta" COVID variant wreak havoc on our personal and professional lives, along with the strains it's causing to our medical community. With that being said, the HCWRT is notifying you of changes in our meetings that take into account the variety of opinions and concerns that in-person meetings bring. Therefore, everyone who attends meetings (for at least the near future) is asked to be aware of the following:

- All persons attending will wear a mask during the meeting. Please bring your own. A few extra masks will be available at the meeting.
- At our brand-new venue, Rudi • Lechner's, dinner will not be served during the course of the meeting, but instead we ask to arrive diners no later than 6:00 p.m. to be served in a designated area the in restaurant's main dining room. Be sure to mention you're with the Houston Civil War Round Table when being seated by Rudi's staff.
- Attendees will order from a regular menu, and will have their own tabs, whether for dinner, appetizers, and/or drinks. Tabs need to be closed by 6:55 p.m. in order for attendees to be in their seats in the separate meeting room by 7:00 p.m. (sharp).
- The HCWRT meeting will begin at 7 p.m. and include the recitation of our Pledge of Allegiance, the speaker's presentation, and a post-presentation question / answer session. HCWRT agenda items (e.g., pertinent membership announcements, book raffle, and other limited business items) also are planned.
- Book sales and signings generally are at the discretion of the

speaker. This month's speaker, Andrew Lang, intends to have a small number of books available for sale and signing.

- Meeting attendees will be seated in rows - "classroom" fashion and in chairs spaced for "social distancing".
- If you feel sick, have a fever, or personally feel you cannot abide by these temporary requirements, we ask that you please stay home. If you cannot attend for any of these reasons, we hope you'll be able to attend future meetings.
- For the time being, this plan is for the September 16 meeting. We will revisit our community COVID status and our meeting plans month by month as long as COVID spiking continues, so please stay tuned for future meeting information in October and beyond.
- As our socially-distanced space in the meeting room is likely limited to some 30 - 35 spaces, it is imperative that attendees adhere strictly to the RSVP requirements shown in the upper left of newsletter (page 1) in order to ensure that a seat is available. Those who do not RSVP by the deadline and walkins will risk not being able to enter the meeting space due to lack of seating capacity.

It is quite possible that HCWRT may once again resume Zoom format meetings. After all, circumstances may progress to a level beyond our control and public meetings could be once While this is certainly not again restricted. anyone's "ideal" scenario and set of circumstances, this is the best plan for us to return to in-person meetings, while at the same time doing so in a safe manner. We think it offers a proactive and thoughtful approach for all concerned. Also, as President Boisaubin states in his column, we will explore having Zoom available for the benefit of those who choose not to attend our in-person meetings.
